Committee Update

Additional Information

Since the publication of the Planning Committee agenda, the following additional information has been received:

- Letter from Drainage Consultant.
- Updated Sustainable Drainage Strategy Report – includes additional information in relation to surface water attenuation for proposed buildings.
- Updated Bat Report – include a table in Section 4 which gives the corresponding tree numbers in the Arboricultural Report and a paragraph added in Section 5.1.1 to include information about trees required to be removed.
- Updated Preliminary Ecological Appraisal – updated to show the candidate Local Wildlife Sites (cLWS) on the existing habitats plan.

Consultations

Since the publication of the Planning Committee agenda, the following additional consultation responses have been received:

Leicestershire County Council, Ecology – Approve, pending production of pre-commencement conditions. Comments that the discrepancy between the location of tree T4 in the bat report and the Arboricultural Impact Assessment has been clarified in Section 4 of the updated bat report. In addition, Section 5.1.1 includes the requested updated detail for which trees require removal. A Natural England licence should be sought for T4 to enable the works in the vicinity to lawfully take place. Proposed mitigation, should be clearly illustrated in the finalised landscape plan.

Leicestershire County Council, Lead Local Flood Authority – Approve with conditions. Comments that subsequent to the previous response, the applicant has provided details of the proposed attenuation for both the outline and full elements of the application. The LLFA would expect the proposals for attenuation volumes in the

outline application to be realised in the submission of reserved matters details. Recommends conditions relating to the surface water drainage scheme being agreed, details of the management of surface water during construction being agreed, and details of the long term management of surface water being agreed.

Planning Considerations

Impact on trees

This section of the report did not refer to the Leicester City Council (Glenfield Hospital NHS Trust) Tree Preservation Order 1993, which protects a number of trees on the site within Leicester City Council's administrative area.

Of those trees protected by the Order, four individual trees would be required to be removed (T383, T384, T385 and T386, which correspond to T7, T8, T9 and T10 in the Arboricultural Report submitted), all horse chestnut trees, in addition to the partial removal of Group 3 (ash trees), referred to as G1 in the arboricultural report.
