2. <u>ELECTION OF CHAIRMAN</u>

3. MATTERS ARISING FROM THE MINUTES

A47 Car Boot

Parishioners raised their concerns about the traffic situation around the site of the A47 Car Boot sale on Sunday mornings.

Councillor E White reported that he would contact the operator of the site in respect of traffic problems.

The response from Councillor E White is as follows:-

On the Sunday in question a vehicle had broken down which had caused considerable problems with the management of the traffic going into and out of the site.

A second access was opened so that the situation could be managed, which is in accordance with the planning permission, and the operator himself stewarded the traffic until the situation was bought under control, it is understood that the Enforcement Officer ant Blaby District Council was happy with how the situation was managed.

The Chairman reported that he had attended a presentation at County Hall by the Chief Constable in respect of Policing the Future – Public Engagement.

He said that the presentation had been very interesting and that there was to be another meeting at the Police Headquarters in June.
