3. THURLASTON COUNTRY PARK - NEW PREMISES LICENCE

Considered – Report of the Senior Technical Officer – Licensing.

The Applicants put forward the case for New Premises Licence with the following amendments:

Questions relating to the case were put to the Applicants by the Sub-Committee.

The Objectors put their case to the Sub-Committee.

Questions relating to the case were put to the Objectors by the Sub-Committee.

The Applicants made a closing speech.

The Sub-Committee then retired to consider the application in closed session.

The Sub-Committee returned to announce its decision.

DECISION

The decision of the Sub-Committee is to grant the application for a new premises licence incorporating the amendments given during the Sub-Committee:

- To permit the sale and supply of alcohol for consumption on the premise everyday from 12:00 to 00:30 hrs.
- To permit plays, films, recorded music, performance of dance between 12:00 to 00:30 hrs.
- To permit live music form 12:00 to 22:30 hrs.
- To permit late night refreshment 23:00 to 01:00 hrs.

Subject to the following conditions:-

- Recorded music shall be played indoors only.
- Should an additional marquee be used, suitable controls will be used as agreed with the Environmental Health department.
- No amplified live music should be played at anytime.
- The sides of the marquee be down by 23:00 hrs.

The Sub-Committee recommends that the applicant provide two telephone numbers to neighbours on request, and also provide hirers details of the best access route should guests be arriving by coach or minibus.

Reason:

In reaching its decision the Sub-Committee has had regard to the submissions and representations of the applicant, the Parish Council and objectors, together with the Council's statement of Licensing Policy and Guidance issued under Section 182 of the Licensing Act 2003.

The Committee acknowledge the representations made by the objectors show legitimate worries about future possibilities, but should these occur they would be dealt with by enforcement procedures.

Having considered all of these factors, the Sub-Committee has decided to grant the revised application, as granting the application would not undermine the four licensing objectives.
