## 1. What is this report about?

1.1 The Licensing Sub-Committee is required to determine an application to vary a premises licence relating to Badgers Mount Hotel, 6 Station Road, Elmesthorpe, Leicestershire LE9 7SG.

### 2. Recommendation

2.1 That the Licensing Sub-Committee determines the application in accordance with the Licensing Act 2003.

Having considered the application and representation(s), Members must consider whether to

- Grant the variation to the licence without modification
- Grant the variation to the licence subject to conditions
- Exclude from the licence any of the licensable activities requested
- Reject the application

Giving full reasons for their decision.

#### 3. Reason for Decision Recommended

3.1 The Licensing Act 2003 requires that the Licensing Sub-Committee determine an application to vary a premises licence when relevant representations are received.

#### 4. Matters to consider

4.1 The Licensing Authority received a complete application to vary the Premises Licence on 25<sup>th</sup> August 2015. The application was submitted in accordance with the requirements of the Licensing Act 2003 by Mr I Poxon & Mrs J Hirons.

The variation application requests the addition of live and recorded music and

anything of a similar description (indoors & outdoors) from 10.00hrs to 00.00hrs Monday to Saturday and 12.00hrs to 22.30hrs on Sunday and that the terminal hour on New Years Eve is 00.30hrs.

The application also details a request to extend the current hours for the sale of alcohol on and off the premises by one hour. The hours requested for the sale of alcohol are Monday to Saturday 10.00hrs to 00.00hrs and that the terminal hour on New Years Eve is 00.30hrs.

The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule.

In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

A copy of the application to vary is attached at Appendix A.

A copy of the current Premises Licence is attached at Appendix B.

## 4.2 Relevant Representations

**Responsible Authorities** – There were no representations received from any of the Responsible Authorities.

#### **Other Persons**

Parish Council – Elmesthorpe Parish Council submitted a representation relating to the prevention of public nuisance. A copy of the representation is attached at Appendix C.

Local Councillor – Cllr David Freer submitted a representation relating to the prevention of public nuisance. A copy of the representation is attached at Appendix D

Local Resident – A letter of representation was submitted from a local resident which relates to the prevention of public nuisance. A copy of the letter of representation is attached at Appendix E.

## 4.3 Appropriate Consultations

The Act requires that the applicant sends a copy of their application to the Licensing Authority and all Responsible Authorities. When the application is accepted the applicant must place a notice detailing the application and the relevant dates for representations to be submitted, once in a local publication and on, at or near to the premises for 28 consecutive days. The Licensing Authority must also display a notice detailing the application on their website for 28 consecutive days commencing on the day after the application has been accepted.

Badgers Mount Hotel have two security staff working during Wedding Receptions and Parties. Our security staff are available up until 2 am if required, to ensure that guests not staying at the Hotel leave the premises promptly and orderly.

## c) Public safety

Our Bar staff are trained with the knowledge not to serve a guest an alcoholic drink if they consider them to be inebriated or causing nuisance. Security staff deal with any nuisance problems to resolve them before they escalate.

## d) The prevention of public nuisance

Badgers Mount Hotel would ensure that any taxi's booked for guests not staying at the Hotel would be by 00:30 latest.

We do display a notice in prominent positions in the Hotel, reminding guests to 'please respect our neighbours and leave the premises quietly'.

## e) The protection of children from harm

Our staff are trained to be vigilant where children are present to ensure their safety.

Our staff are trained and reviewed to follow the Challenge 21 policy, to ensure that we do not serve alcohol to underage guests.

## **ANNEX 1 - MANDATORY CONDITIONS**

No supply of alcohol may be made under the premises licence -

a) at a time when there is no designated premises supervisor in respect of the premises licence, or

b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

- 1. (1) the responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licence objective
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or

glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner:

- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person shall ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 yeas of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
  - (a) a holographic mark, or
  - (b) an ultraviolet feature

4. The responsible person must ensure that -

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
- (iii) still wine in a glass: 125ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available. (

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979 (a)
- (b) "permitted price" is the price found by applying the formula

## Where

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- the holder of the premises licence
- the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply under such a licence;
- (d) "Relevant person" means in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994 (b)

Where the permitted price given by paragraph (b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- (1) Sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

The restrictions in this Annex do not prohibit any sale, supply or consumption of alcohol previously permitted by the Licensing Act 1964.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal.

Licensable activities may continue between the end of the hours permitted by the licence on New Years Eve and the start of the hours permitted by the licence on New Years Day.

No person under fourteen shall be in the bar of the licensed premises during the hours that the premises is licensed for the sale of alcohol, except as previously permitted by the Licensing Act 1964.

### ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Intoxicating liquor shall not be sold or supplied on the premises otherwise than to:-

Persons residing there or their private friends bona fide entertained by them at their own expense, and for consumption by such a person or his private friend so entertained by him either on the premises or with a meal supplied at but to be consumed off the premises.

There shall be afforded in the premises, for persons provided with board and lodging for reward, adequate sitting accommodation in a room, not used or to be used for sleeping accommodation, for the service of substantial refreshment or for the supply or consumption of intoxicating liquor.

Suitable beverages other than intoxicating liquor (including drinking water) shall be equally available for consumption with or otherwise as an ancillary to meals served in the premises.



Application for Extension of Licensable Activities to Midnight at Badgers Mount Hotel Elmesthorpe

Elmesthorpe Parish Council objects to this application for the reasons set out below:

1. Badgers Mount Hotel is located in a residential area in Elmesthorpe village. This application is to extend the Licensable Activities for the sale by retail of Alcohol and the Provision of Regulated Entertainment, both to finish at Midnight. If the extension is granted, it would permit the playing of music, both recorded and live music, on the Hotel premises including in the Hotel gardens, until midnight in a quiet residential area every night of the week.

Whilst the application is for an extension to midnight, if it is granted, once the alcohol sales, entertainment or music have finished at midnight, any customers not resident at the Hotel will leave either on foot or by car so the noise disruption to people living in nearby homes is likely to be until 12.30am. Of particular concern is the noise of car doors slamming at this time of the day when the rest of the village is quiet.

The Parish Council is very concerned about the adverse impact of the noise on the residents living nearby, and the general detriment to their quality of life.

- 2. A number of the trees and bushes around the Hotel which previously helped to reduce the impact of noise from the Hotel have recently been reduced or removed. The green area along the front perimeter of the Hotel have been cut back reducing the "acoustic baffle", and some of the trees and bushes on the car park's central island in front of the Hotel have been removed, thereby removing the screening which had previously reduced the impact of the noise from the Hotel on the people living in the homes opposite the Hotel.
- 3. There is also an issue with the lighting on the front of the Hotel which, since the reduction and removal of the trees, shines directly into the bedrooms of the homes opposite the Hotel. The lighting is on during evening opening hours and until customers leave at the end of the evening, so with the

current licensable activities ending at 11pm, the nearby residents can expect the lighting to be at a reduced level by 11.30pm. However licensable activities are extended to midnight, then the lighting is unlikely to be at a reduced level until 12.30am which the Parish Council considers is wholly unreasonable.

In view of the above matters set out above, the Parish Council would ask that the application for an extension to midnight is refused.

I live at Uppingham; Station Road in Elmesthorpe which is almost opposite Badgers Mount Hotel.

My husband and I are extremely concerned by an application by the new owners of the hotel to extend both the sale of alcohol and regulated entertainment until midnight on every night of the week.

This presumably means that cars will be departing until at least 1230 and quite possibly much later; and this could become a nightly occurrence which we consider to be totally unacceptable in a predominantly residential area.

t is also likely to be extremely noisy until very late if the entertainment is being held outside - with music being allowed to play until midnight.

To summarise we strongly oppose the application; we consider 1130pm on Friday and Saturday to be more reasonable; this would ensure that cars depart hopefully by midnight or not much after; it would also protect residents from disturbance during the working week – when 1030pm seems nore than adequate.




