1. What is this report about?

1.1 The Licensing Sub-Committee is required to determine an application to vary a premises licence BLPR0082, relating to Badgers Mount Hotel, 6 Station Road, Elmesthorpe, Leicester, LE9 7SG.

2. Recommendation

2.1 That the Licensing Sub-Committee determines the application in accordance with the Licensing Act 2003.

Having considered the application and representations, members must consider whether to

- Grant the licence variation without modification
- Grant the licence variation subject to conditions
- Reject the application

Members must give full reasons for the decision made

3. Reason for Decision Recommended

3.1 The Licensing Act 2003 requires that the Licensing Sub-Committee determine a variation of a premises licence where relevant representations are received

4. Matters to consider

4.1 Background

The Licensing Authority received a complete application for a variation to a premises licence for the Badgers Mount Hotel on 4th October 2021. The application was submitted in accordance with the requirements of the Licensing Act by the applicant: Mr Glen Watson, and requested the following variations to the activities authorised by the current premises licence:

- To request the hours for the supply of alcohol (on the premises), live music (indoors), and recorded music (indoors) be changed to:
 - Every day 11.00hrs 23.59pm

 Additional non-standard timings: New Year's eve 00.00hrs -02.00hrs

A copy of the full application is attached at Appendix A.

The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (Section M).

A copy of the existing premises licence is attached as Appendix B.

4.2 Relevant Representations

Responsible Authorities - Leicestershire Police have agreed conditions with the applicant in order to promote the licensing objectives, namely the Prevention of Crime and Disorder. If the application is granted, these conditions will be transferred to the premises licence. A copy of these agreed conditions is attached as Appendix C.

Other Persons - Representations were received from 22 other persons. The representations cover aspects of all four of the licensing objectives. Copies of these representations are attached as Appendix D.

4.3 Appropriate Consultations

The Act requires that the applicant sends a copy of their application to the Licensing Authority and all Responsible Authorities. When the application is accepted the applicant must place a notice detailing the application and the relevant dates for representations to be submitted, once in a local publication and on, at or near to the premises for 28 consecutive days. The Licensing Authority must also display a notice detailing the application on their website for 28 consecutive days commencing on the day after the application has been accepted. All of the above requirements were complied with.

4.4 Significant Issues

Human Rights have been considered but there are no overarching matters for concern in relation to this report. There are no specific legal or Human Resources implications. There is no requirement for an EINA or DPIA.

Badgers Mount Hotel have two security staff working during Wedding Receptions and Parties. Our security staff are available up until 2 am if required, to ensure that guests not staying at the Hotel leave the premises promptly and orderly.

c) Public safety

Our Bar staff are trained with the knowledge not to serve a guest an alcoholic drink if they consider them to be inebriated or causing nuisance. Security staff deal with any nuisance problems to resolve them before they escalate.

d) The prevention of public nuisance

Badgers Mount Hotel would ensure that any taxi's booked for guests not staying at the Hotel would be by 00:30 latest.

We do display a notice in prominent positions in the Hotel, reminding guests to 'please respect our neighbours and leave the premises quietly'.

e) The protection of children from harm

Our staff are trained to be vigilant where children are present to ensure their safety.

Our staff are trained and reviewed to follow the Challenge 21 policy, to ensure that we do not serve alcohol to underage guests.

ANNEX 1 - MANDATORY CONDITIONS

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

- 1. (1) the responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licence objective
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner:
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person shall ensure that free potable water is provided on request to customers where it is reasonably available.
- **3.** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 yeas of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
 - (a) a holographic mark, or
 - (b) an ultraviolet feature
- **4.** The responsible person must ensure that -
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
- (iii) still wine in a glass: 125ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
- (b) "permitted price" is the price found by applying the formula

$$P = D + (D \times V)$$

Where

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply under such a licence;
- (d) "Relevant person" means in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994

Where the permitted price given by paragraph (b) above would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

(1) Sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second

day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

The restrictions in this Annex do not prohibit any sale, supply or consumption of alcohol previously permitted by the Licensing Act 1964.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal.

Licensable activities may continue between the end of the hours permitted by the licence on New Years Eve and the start of the hours permitted by the licence on New Years Day.

No person under fourteen shall be in the bar of the licensed premises during the hours that the premises is licensed for the sale of alcohol, except as previously permitted by the Licensing Act 1964.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Intoxicating liquor shall not be sold or supplied on the premises otherwise than to:-

Persons residing there or their private friends bona fide entertained by them at their own expense, and for consumption by such a person or his private friend so entertained by him either on the premises or with a meal supplied at but to be consumed off the premises.

There shall be afforded in the premises, for persons provided with board and lodging for reward, adequate sitting accommodation in a room, not used or to be used for sleeping accommodation, for the service of substantial refreshment or for the supply or consumption of intoxicating liquor.

Suitable beverages other than intoxicating liquor (including drinking water) shall be equally available for consumption with or otherwise as an ancillary to meals served in the premises.

All staff will be trained to impliment Challenge 21 and a periodic review of the training will be undertaken.

A log of refused sales will be kept at the premises and reviewed by the DPS on a regular basis to highlight any patterns.

A local resident has kindly advised that this is the email address we can use to voice our objections to a license application. (see image attached)

If this is not the correct address or department, please advise where to direct my objection.

There is no reference number for this application, nor am I able to find the application online. Is this still being pursued?

The application is for a local business, Badgers Mount Hotel, to extend their events license and therefore permission for making noise pollution late into the night during the week.

Whilst I completely understand the relevance of this requirement from Friday to Sunday, when the majority of the general public arrange special occasions, i.e. weddings, the need to for this to continue throughout the week shows blatant disregard to the effect on the local community, and properties with close proximity to the establishment.

Over recent months there has been repeated occasions where Badgers Mount have disturbed the neighbourhood, consistently playing loud music, audible 200m away and others significant events, involving fairground rides on one occasion, and cars parked along the main road and side streets on several occasions. The noise from these events has woken my young son on several occasions, and also keeps me awake until the guests have all dissipated.

In a world where we are still learning to manage to live with Covid-19, events so far have been reduced in size yet still hugely disruptive. My concern is that as we continue to normalise, these events will continue to grow both in size of attendees, volume, and traffic. Also if this extension is approved, what prevents another application in the future extending the time even further?

I would like to think that due consideration would be given to the effect that this would have on people's working lives and children's school lives if they needed to try to function on constantly disrupted sleep. We as residents, in close proximity and directly affected by this change, would appreciate a firm line in the sand to be drawn and remain in place with the current license, to maintain the quiet, rural village environment which attracted us to move here.

There is a blatant disregard the Management hold for the rules imposed upon it by the council, and also towards their fellow village residents. Therefore, I wish to formally, and **strongly, object** to the proposed extension to the license at Badgers Mount Hotel.

It is my understanding that at the moment Badgers Mount Hotel holds its license until 11pm Sunday-Thursday and midnight on Friday and Saturday. They wish to extend this licence to midnight 7 days per week.

Currently, they host large wedding or party-style events on Fridays and Saturdays (and occasionally other days) but on those occasions where such events are hosted the noise levels are simply unacceptable. When live bands are playing I could tell you what song is being played from my lounge (at the back of my house) with the television on and the windows closed. Recorded music is slightly less invasive but I can still feel and hear the bass resonating and any event held on the premises with music never makes for a good night's sleep.

Guests drinking outside up until midnight and the noise they make leaving after midnight frequently disrupt us, alongside the movement and activities of staff leaving and emptying bins/glasses etc.

Parking is always a problem, I cannot safely see to get off my drive on some occasions and cars parked on the main road can only be seen as a major hazard. This road is 40mph and is a busy stretch of road, often used by lorries, tractors, horses and cyclists. Pedestrians, prams and wheelchairs sometimes cannot use the narrow pavements due to people parking on them, and residents in nearby residential streets often have problem with inconsiderate and excessive parking also (Leighton Crescent, Roundhills, Bostock Close).

In summary, the events that take place with a late license are very, very disruptive to the residents of Elmesthorpe; to extend this for us to experience all week long is unacceptable. My little boy is already woken up by the noise, as are we; it is extremely annoying as it is but at least it is a weekend. To have to experience this on nights where he needs to go to school, for us to go to work, for traffic to be negotiating cars parked along the road during rush hour/school bus drop offs and pick ups is absolutely not an option.

I am aware that planning permission was granted for the marquee to become a permanent addition, and I am also aware that it came with some strict caveats regarding noise and how they control it. These noise restrictions are absolutely NOT being adhered to, especially for live bands. I don't know how they measure the noise output but for me to be able to sing along in my home, and my son be woken from his sleep, is not acceptable and I simply cannot understand how we will cope if the license is extended allowing and encouraging this establishment to host such events all week long.

As such, Sunday through until Thursday with the 11pm license means that the Hotel seems not to host large parties and is therefore, much more in keeping with its location amongst

residential homes in a quiet, semi-rural village. I think with the disruption that the residents face over a weekend, that it only seems reasonable to allow us some sleep and to enjoy our homes during the week please.

Thank you very much for your time taken to read and consider the points in my email. I sincerely hope that the long-suffering residents of Elmesthorpe are considered and this license extension is not approved.

Thank you for your email of 26 October 2021 regarding the application to vary various parts of the current Licence at The Badgers Mount Hotel, Elmesthorpe. In the light of the comments received from residents living near to Badgers Mount, Elmesthorpe Parish Council wishes to object to the application.

The grounds for objection are:

 To safeguard the living conditions of nearby residents. Badgers Mount is located in a wholly residential area in a small village. Despite the Applicant's assurances about the way in which activities will be run on the premises, we understand from residents that he has repeatedly shown scant regard for their wellbeing.

The Parish Council understands that residents have telephoned Badgers Mount Hotel on a number of occasions and asked for the music to be turned down simply to be told "it does not exceed the decibel level" and the music was not turned down. Furthermore, we understand that the level of noise from Badgers Mount has been such that residents living on the opposite side of the road are unable to hear their televisions.

- The extension to midnight on every day of the week of the performance of live music and the
 playing of recorded music to midnight on every day of the week is likely to make the lives of
 those living close by intolerable.
- The music played at Badgers Mount can be heard more than half mile away at homes on Burbage Common Road. The Parish Council (and we also believe that the Planning Department) has been contacted by residents of Burbage Common Road who have complained that their use of their homes was being spoilt by the noise generated by Badgers Mount Hotel. In particular, the loud noise had disturbed use of their garden on an almost weekly basis during the last couple of years.

- The impact of the noise on the lives of people in Elmesthorpe is such that the Planning
 Officers felt the need to specifically address it when the Applicant applied to retain the on site
 marquee on a permanent basis. The planning permission also specifically requires that
 external doors and openings shall be kept closed in the interests of the living conditions of
 nearby residents.
- To illustrate the Parish Council's concerns about the Applicant's lack of consideration of his neighbours, we would refer to the Applicant's activities at the end of August 2021. The Applicant had already been made aware by the Planning Department of concerns within the Village about the disruption caused by his clients parking on the Station Road. The Planning Department were sufficiently concerned about the situation to attached a condition to the planning permission for the retention of the marquee whereby a Parking Management Plan must be submitted for approval in the interests of highway safety and to minimize the level of on street parking.

This planning permission is very recent, having been granted on 17 May 2021. In response, on a date believed to be the last Sunday in August 2021, the Applicant installed or allowed to be installed two large fairground amusements in the car park so his clients were forced to park on the road causing severe disruption to traffic. From this, the Parish Council can only assume that the Applicant has no interest in working with the local community and little regard for the wishes of Blaby District Council's Planning Team.

We understand with considerable concern that the proprietor of the Badgers Mount Hotel has applied for an extension to the hours of operation permitted at the premises.

The hours applied for will allow the premises to serve alcohol as well as play live and recorded music from 11am until 2359 for 365 days every year.

As we live diagonally opposite the premises we will be significantly affected by these proposals if they are permitted.

There have already been occasions of music being played at excessive volume pre COVID; mainly because a marquee is used which has little sound proofing - it is totally unacceptable to be subjected to this without any respite - if this licence is granted it will potentially be 13 hours every day!

We are concerned that the revised hours if allowed will lead to a public nuisance and are excessive for a hotel in a rural area. I doubt they would even be welcomed in a town centre!!

Elmesthorpe is a rural location without a shop; public car parking or public transport. This means that most customers will arrive and leave by car causing additional traffic as well as noise in the early hours of the morning.

As a village Elmesthorpe does not the facilities which often accompany this kind of activity. There is no police presence; no CCTV; no taxi rank.

Cars which cannot be accommodated within the hotel car park will doubtless be parked on the surrounding roads as was the case several weeks ago when the proprietor permitted a fair to be operated in the hotel car park until late evening. Cars were parked all along the main road and on grass verges until very late.

We are also concerned that if the premises are allowed to open later than anywhere else in the immediate area without restriction the hotel bar may become a magnet for late night drinkers who have been in nearby venues which have closed earlier.

Whilst appreciating that the proprietor of Badgers Mount obviously wants to operate a profitable business the premises are a hotel - not a night club.

We request that the licensing application is denied.

Since moving here in 2016 we have witnessed the growth of this business from it's humble beginnings into a thriving restaurant and also enjoying greater hotel occupation through many weddings and party guests. I am glad to see any thriving business in our community but not at any cost, certainly the increase in traffic is now causing great concern amongst locals. The most serious concern expressed by residents is the general increase in noise created but parties and party goers. There also used to be a once a year firework experience in November in our community when all people celebrate bonfire night. Now we have this many times throughout the year due to parties and weddings held at 'Badgers'. Guests expect a display with their celebration but we the local residents must tolerate not fireworks for families but Display fireworks which along with frightening some elderly residents also send the resident animals into stress. There is no 'set' timescale for the length of the display so the elderly that like to retire early have little chance of rest.

I have mentioned the above paragraph to demonstrate exactly what we the residents must tolerate already to allow this business to be profitable and employ people both in and out of our community. I also think that some consideration must now be given to that community and say to the owners of Badgers Mount, if you wish to be part of this community you must look at other ways of improving the viability of your business. This is more likely if you work with the community and not constantly against them.

The recent approval of the 'Gazebo' in the grounds has also been an unwelcome addition to the overall noise levels that are no longer contained within the building but now with music playing loudly for wedding guest is something else we are expected to embrace for the sake of business growth.

On the whole my experience of Blaby Council since we moved here has been a very good one, they being receptive, helpful and providing good facilities in our area for children, dog owners and the community to enjoy.

Keeping these facilities well maintained.

With regard to the above application, as residents directly opposite to the premises in question, we would like to protest to the application due to the following reasons:

1. Public nuisance and public safety

At present under the existing licence they hold, we are already subjected to excessive noise levels after 1.00 am

The traffic is increased at night when functions are being held, and this is on an already very busy main road, through the village.

Taxis arriving and departing and parking along the main road on the verges are definitely a safety issue. There is insufficient parking on the premises.

We moved into our property in May this year and there have been functions generally every weekend since Covid restrictions have been lifted. Whereas we are delighted that life is getting back to normal, we are very unhappy with the fact that a relatively small hotel and restaurant is being turned into an events venue. Obviously, if the licence is granted the noise levels and traffic levels will increase significantly and at present with the existing licencing hours, during the summer months we have already been unable to have our bedroom windows open at night.

A few weeks ago there was a fairground attraction erected for a wedding function, which caused chaos on the main road and although part of the equipment which was at the front of the hotel was closed down at 9.00p.m the other equipment and loudspeakers were still continuing into the early hours. The noise from the guests was excessive.

Elmesthorpe is a residential village and we feel that these premises should remain as a small country hotel and restaurant to be enjoyed by the residents and public alike, and not be turned into a noisy, unsavoury venue.

We are extremely disappointed to find that having moved into this village location it is possible that there will be a total disregard by Blaby Council, to the quality of life for the residents of Elmesthorpe and the safety of the public using this main route.

We hope you will consider our concerns before granting this licence.
