**252. APPLICATION TO VARY A PREMISES LICENCE - MORRISONS, 29  
POCHIN STREET, CROFT, LEICESTERSHIRE LE9 3HA.**

Considered – Report of the Licensing Team Leader.

The Licensing Team Leader presented the report.

The Applicant put forward their case to vary the Premises Licence.

The Objectors presented their representations.

The Applicant gave a closing speech.

The Sub-Committee then retired at 1:37pm to consider the application in closed session.

The Sub-Committee returned at 1.55pm to announce its decision.

**DECISION**

In reaching its decision the sub-committee has had regard to the representations of the applicant and objectors, together with the Councils statement of licensing policy and guidance. The variation to the license is approved subject to the following conditions:

1. All staff will be instructed to be considerate to neighbours when arriving or departing the premises so as not to cause a noise nuisance.
2. There shall be no inbound deliveries between the hours of 2000 and 0700.
3. No music shall be played inside the store so as to cause a likely disturbance to residents.
4. Any 3rd party couriers will be instructed to be considerate to neighbours when arriving or departing the premises so as not to cause a noise nuisance.

Reason:

The Sub-Committee having listened to all of the representations were satisfied that a 24H hour alcohol licence would allow the 4 licensing objectives to be met and adhered to and that it addresses the concerns in relation to public nuisance.
