1. What is this report about?

1.1 The Licensing Sub-Committee is required to determine an application for a Temporary Event Notice for The Nags Head Public House, 41 Cross Street, Enderby LE19 4NJ.

2. Recommendation

- 2.1 That the Licensing Sub Committee determines an application for a Temporary Event Notice in accordance with the Licensing Act 2003. Having considered the application and objections, members must consider whether to:
 - Grant the Temporary Event Notice without modification
 - Grant the Temporary Event Notice subject to conditions
 - Decide that the event would undermine the licensing objectives and should not take place

Members must give full reasons for any decision made.

3. Reason for Decision Recommended

3.1 The Licensing Act 2003 requires that the Licensing Sub Committee determine a Temporary Event Notice when an objection notice is received from the Environmental Health Department.

4. Matters to consider

4.1 Background

The Licensing Authority received an application for a Temporary Event Notice from The Nags Head Public House on 22nd May 2025. The application was submitted in accordance with the requirements of the Licensing Act by the applicant and requested the following Temporary Event Notice be approved for the premises for an event on 7th June 2025:

 Live acoustic music to be performed at the premises from 17:00 to 19:30 in the garden area on the 7th June 2025 for a maximum of 200 people.

A copy of the application for a Temporary Event Notice is attached at Appendix A.

A copy of the existing premises licence is attached as Appendix B, this was granted following a hearing on 27th September 2005. The decision notice correspondence from this hearing is attached at Appendix C.

4.2 Relevant Representations

Objections-

Responsible Authorities – An objection was received from Blaby District Councils, Technical Officer. A copy of this objection is attached at Appendix D.

No objection was received from Leicestershire Police.

ANNEXES

ANNEX 1 - MANDATORY CONDITIONS

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

- 1. (1) the responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licence objective
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person shall ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
- (a) a holographic mark, or
- (b) an ultraviolet feature
- 4. The responsible person must ensure that -
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
- (i) beer or cider: half pint;
- (ii) gin, rum, vodka or whisky: 25ml or 35ml; and
- (iii) still wine in a glass: 125ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1

- (a) "duty" is to be construed in accordance with the Alcoholic Li quor Duties Act 1979
- (b) "permitted price" is the price found by applying the formula

$$P = D + (D \times V)$$

Where

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply under such a licence;
- (d) "Relevant person" means in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994

Where the permitted price given by paragraph (b) above would (a part from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- (1) Sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, exce pt alcohol sold or supplied with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal.

Licensable activities may continue between the end of the hours permitted by the licence on New Year's Eve and the start of the hours permitted by the licence on New Year's Day.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

To permit the opening of the premises, supply of alcohol and recorded music for a further additional hour on the standard timings every Friday, Saturday, Sunday and Monday for each May, Spring/Whitsun Bank holiday and every August Bank holiday weekend. An additional hour into the morning following every Thursday, Friday, Saturday, Sunday and Monday for the Easter Bank holiday weekend. An additional hour every Christmas Eve and Boxing Day.

External lighting all round vision, burglar alarm in use. All trading areas are visible from the bar servery. Customer's behaviour is monitored regularly.

Firefighting equipment with a service agreement in place. Gas and electrical certificates in force. Smoking charter in place. Disability discrimination assessment completed and the disabled catered for. Health and Hygiene Certificate in place.

Noise survey completed on a regular basis. Fabric of building retains sound. Customer departures are managed and monitored.

No unaccompanied children are allowed on the premises. No nudity, striptease or age restricted films will be held on the premises.

Licensing Act 2003 (Hearing) Regulations 2005 - Section 28 and 29 Nags Head, Enderby, Leicester

I refer to your application for a Premises Licence for the Nags Head Public House, Enderby, Leicester.

At the hearing that was held on 27th September 2005, the Licensing Authority agreed to grant a licence subject to the following amendment and condition, in addition to the conditions consistent with the operating schedule.

- a) Amendment to the operating schedule and additional condition:
 - Amplified music not to be audible beyond the curtilage of the premises.

You may appeal against this decision by writing to the Chief Executive to the Magistrates at Hinckley Magistrates Court, The Courthouse, Upper Bond Street, Hinckley, Leicestershire, LE10 1NZ within 21 days of the date of this letter. The court may:-

- a) dismiss the appeal
- b) substitute any other decision which could have been made by the Licensing Authority, or
- c) return the case to the Licensing Authority to dispose of it in accordance with the direction of the court

and may order costs as the court thinks fit.

Temporary Event Notice - LIC716751727 The Nags Head, 41 Cross Street, Enderby, LE19 4NJ

<u>Proposal</u>: music event (tribute act) in garden area – 2x 45 minute sets between 17:00 and 19:30, amplified through use of speakers.

<u>Note</u>: advertised online (Facebook page) as commencing from 18:00. Contents of TEN discussed with applicant to obtain further information – applicant advised of 2x 45-minute sets between 17:00 and 19:00.

Objection

Objection to TEN on grounds as does not meet licensing condition Prevention of Public Nuisance. An unlicensed outdoor music event was held in the beer garden of the premises on 9 May 2025, which led to complaints of unreasonably loud noise from residents in the vicinity. This is an ongoing investigation.

The applicant has been informed of the complaint and investigation and has been advised to refer to current premises license conditions.

The TEN in question is for another outdoor music event approx. 4 weeks after the previous event. The set-up proposed by the organisers appears to have little difference from the previous event and is likely to result in the same complaints.

The applicant has given assurances to "ask performers to manage sound levels and keep speaker volume at a reasonable level". I have concerns that this is vague and unable to be satisfactorily enforced by the applicant – what is a reasonable within a beer garden (where the music is sharpest) is not the same as what is heard within the vicinity (sound is distorted when bounced off surfaces and over distance).

Environmental Health is not satisfied that the suggestions made by the applicant will mitigate noise or prevent public nuisance, in line with the licensing objectives.

Additional note:

A history of complaints regarding noise from the premises shows that there is an issue of noise affecting residents within the area. The current premises licence granted in 2005 has specific conditions relating to noise which were attached to the premises licence following a hearing.
