**3. APPLICATION FOR A PREMISES LICENCE AT ENDERBY MINI MARKET,
55 JOHN STREET, ENDERBY LE19 4LF**

Considered – Report of the Licensing Team Leader.

The Licensing Team Leader presented the report.

The Applicant put forward their case for a Premises License relating to Enderby Mini Market, 55 John Street, LE19 4LF.

The Sub-Committee asked questions of the Applicant.

Josh Sanchez, a resident objecting to the application for the premises licence read out his representation.

The Sub-Committee then retired at 6.07 pm to consider the application in closed session.

The Sub-Committee returned at 6.33 pm to announce its decision.

DECISION

The Committee has taken the decision, with full consideration of the concerns raised by the objectors which primarily relate to parking and public safety. The panel has noted that planning permission has not yet been obtained for this premises to run as an off licence. Parking will be a consideration of planning and it is not directly related to the Licensing Objectives that this panel needs to have regard to. It is also noted that there has been no objections raised by the Police as a statutory consultee and should any anti-social behaviour become an issue as a result of this premises selling alcohol the Police can raise an objection and the licence can be subject of a review.

On that basis; the decision of the panel is that the application for a Premises Licence relating to Enderby Mini Market, 55 John Street Enderby be granted subject to the conditions set out below:

1. To permit the hours available to supply alcohol for consumption off the premises, and the hours the premises are to be open to the public to be between 07:00 to 21:00 hours every day.
2. The Premises Licence Holder will adopt a 'Challenge 25' Policy and provide adequate, documented training for staff before they are allowed to sell alcohol.
3. The Premises Licence Holder will ensure that internal and external CCTV is installed and operate an effective CCTV system which is to be maintained in good working order at all times the premises are open.

Reasons:

1. The hours be set at 07:00 to 21:00 due to the store being located in a residential area and also to satisfy the Prevention of Public Nuisance.
2. The 'Challenge 25' Policy satisfies the objective relating to the Protection of Children from Harm.
3. The installation of CCTV satisfies the objectives relating to Public Safety and the Prevention of Public Nuisance.
